## Acknowledgement of Risks, Waiver and Release, and Indemnity

## **Events, Workshops and Arts Classes with Free-Ranging Animals Participation Agreement**

This document serves as a formal waiver, release, and indemnity agreement ("Agreement") for participation in the Events, Workshops, and Arts Classes with Free-Ranging Bunnies and other animals ("Event"). By clicking the checkbox below, you acknowledge and agree to the following terms:

1. Acknowledgement of Risks I acknowledge that participation in the Event involves physical activity and may include interaction with free-ranging animals, including but not limited to bunnies. The activities will take place both indoors and outdoors on a farm, and as such, may involve inherent risks, including but not limited to tripping, falls, injuries from animals, environmental hazards, and other physical injuries.

I understand that the free-ranging bunnies may have unpredictable behavior, and interactions with them may pose additional risks. Bunnies and other animals on the farm may act in ways that are difficult to anticipate, and I accept the risks associated with their presence during the class.

Additionally, I understand that the farm environment may include uneven terrain, farming equipment, and other outdoor hazards that could cause injury. I acknowledge that the outdoor areas may be subject to interactions with other wild animals such as reptiles and bugs and weather conditions such as rain, mud, or heat, all of which could create further risks.

**2. Waiver and Release** By signing this agreement, I hereby release, waive, discharge, and hold harmless the instructors, facility owners, farm owners, staff, and any other associated persons or entities ("Released Parties") from any and all liability for any injuries, damages, or losses that I may suffer, including personal injury, death, or property damage, arising from or related to my participation in the Event, whether caused by the negligence of the Released Parties or otherwise.

I further agree not to bring any legal action against the Released Parties for any injury or damage suffered during my participation in this Class.

- **3. Indemnity** I agree to indemnify, defend, and hold harmless the Released Parties from any and all claims, demands, actions, suits, judgments, and any other legal proceedings arising out of or in connection with my participation in the Event, including any claims made by third parties, whether such claims arise from my own actions, the actions of the animals, the farm environment, or the negligence of the Released Parties.
- **4. Medical Information** I affirm that I am in good health and capable of participating in the Event. I have disclosed any relevant medical conditions to the instructor prior to participating. If at any time during the class I feel unwell or unable to continue, I will immediately inform the instructor and discontinue my participation.
- **5. Assumption of Responsibility** I am responsible for ensuring that my own safety and well-being are maintained during the event or class. I will follow all instructions provided by the host or instructor and take necessary precautions to avoid injury or harm. I understand that the farm environment may present additional challenges, and I will exercise caution, particularly in outdoor areas.

- **6. Consent to Photography and Video** I grant permission for photographs and videos to be taken during the class, and I understand that these images or videos may be used for promotional purposes. If I do not wish to appear in any photographs or videos, I will inform the host or instructor prior to class.
- **7. Governing Law** This Agreement shall be governed by and construed in accordance with the laws of Ontario, Canada, the province in which the class is held.
