

## **Acknowledgement of Risks, Waiver and Release, and Indemnity**

### **Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies and Other Animals Participation Agreement**

This document serves as a formal waiver, release, and indemnity agreement ("Agreement") for a child's participation in the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies ("Class"). By signing below, I, the undersigned parent or legal guardian, acknowledge and agree to the following terms on behalf of my child ("Participant"):

**1. Acknowledgement of Risks** I acknowledge that participation in the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies involves physical activity and interaction with free-ranging animals, including but not limited to bunnies. These activities will take place both indoors and outdoors at a farm, and may involve inherent risks, including but not limited to tripping, falls, injuries from animals, environmental hazards, and other physical injuries.

I understand that the free-ranging bunnies may have unpredictable behavior, and interactions with them may pose additional risks. The animals may act in ways that are difficult to anticipate, and I accept these risks on behalf of my child. I further acknowledge that the farm setting includes both indoor and outdoor areas that may present physical risks, including uneven terrain, farming equipment, and exposure to weather conditions such as rain, heat, or mud.

**2. Waiver and Release** By signing this agreement, I, on behalf of the Participant and myself, hereby release, waive, discharge, and hold harmless the instructors, camp organizers, farm owners, facility owners, staff, and any other associated persons or entities ("Released Parties") from any and all liability for any injuries, damages, or losses that my child may suffer, including personal injury, death, or property damage, arising from or related to the Participant's involvement in the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies, whether caused by the negligence of the Released Parties or otherwise.

I further agree not to bring any legal action against the Released Parties for any injury or damage suffered by the Participant during this program.

**3. Indemnity** I agree to indemnify, defend, and hold harmless the Released Parties from any and all claims, demands, actions, suits, judgments, and any other legal proceedings arising out of or in connection with the Participant's involvement in the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies, including any claims made by third parties, whether such claims arise from the Participant's actions, the actions of the animals, or the negligence of the Released Parties.

**4. Medical Information** I affirm that my child is in good health and capable of participating in the activities associated with the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies. I have disclosed any relevant medical conditions, allergies, or other concerns to the camp organizers prior to the start of the program. If at any time during the program, the Participant feels unwell or is unable to continue, I will be contacted and agree to pick up my child promptly.

**5. Assumption of Responsibility** I understand that the safety and well-being of my child are my responsibility, and I agree to ensure that they are prepared for the class. I also acknowledge that the camp instructors and staff will supervise the Participant, but I am responsible for ensuring my child follows instructions and takes necessary precautions to

avoid injury or harm.

**6. Supervision and Behavior Expectations** I understand that my child will be supervised by camp staff during the activities, including interactions with free-ranging bunnies and outdoor exploration. I agree to discuss the importance of following safety rules and respecting animals and the farm environment with my child before participation. In the event that my child does not follow safety protocols or displays unsafe behavior, I understand they may be asked to leave the activity, and I will pick them up immediately.

**7. Consent to Photography and Video** I grant permission for non-identifying photographs and videos to be taken during the camp or workshop, and I understand that these images or videos may be used for promotional or educational purposes. If I do not wish my child to appear in non-identifying photographs or videos, I will inform the camp organizers prior to the start of the program.

**8. Governing Law** This Agreement shall be governed by and construed in accordance with the laws of Ontario, Canada, the province in which the camp is held.

**By checking the box to this Agreement, I acknowledge that I have read and understood the above terms, and I voluntarily agree to assume all risks associated with my child's participation in the Children's Summer Day Camp / Daytime Drop-Off Workshop with Free-Ranging Bunnies.**
